## Us Alliance Corp Rank 4 of 28



The relative strengths and weaknesses of Us Alliance Corp are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Us Alliance Corp compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 29% points. The greatest weakness of Us Alliance Corp is the variable Other Expenses, reducing the Economic Capital Ratio by 17% points.

The company's Economic Capital Ratio, given in the ranking table, is 27%, being 13% points above the market average of 14%.
