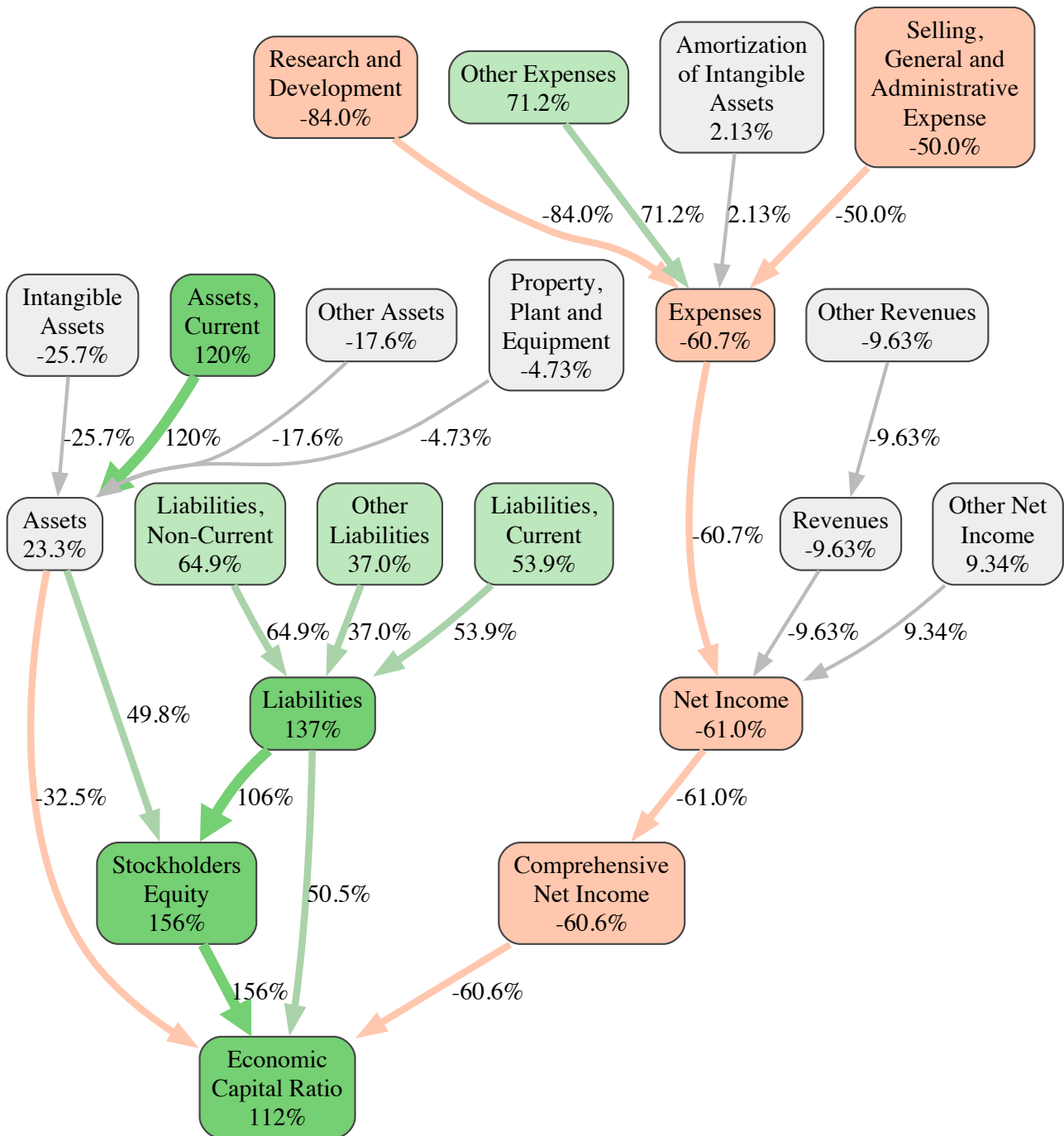

The greatest strength of Credo Technology Group Holding Ltd compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 120% points. The greatest weakness of Credo Technology Group Holding Ltd is the variable Research and Development, reducing the Economic Capital Ratio by 84% points.

The company's Economic Capital Ratio, given in the ranking table, is 273%, being 112% points above the market average of 161%.
