

The relative strengths and weaknesses of WESTPORT FUTURES FUND L.P. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WESTPORT FUTURES FUND L.P. compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 38% points. The greatest weakness of WESTPORT FUTURES FUND L.P. is the variable Net Income, reducing the Economic Capital Ratio by 42% points.

The company's Economic Capital Ratio, given in the ranking table, is 169%, being 13% points above the market average of 156%.
