

The greatest strength of MAN FRM MANAGED FUTURES STRATEGIES LLC compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 26% points. The greatest weakness of MAN FRM MANAGED FUTURES STRATEGIES LLC is the variable Net Income, reducing the Economic Capital Ratio by 59% points.

The company's Economic Capital Ratio, given in the ranking table, is 151%, being 4.9% points below the market average of 156%.
