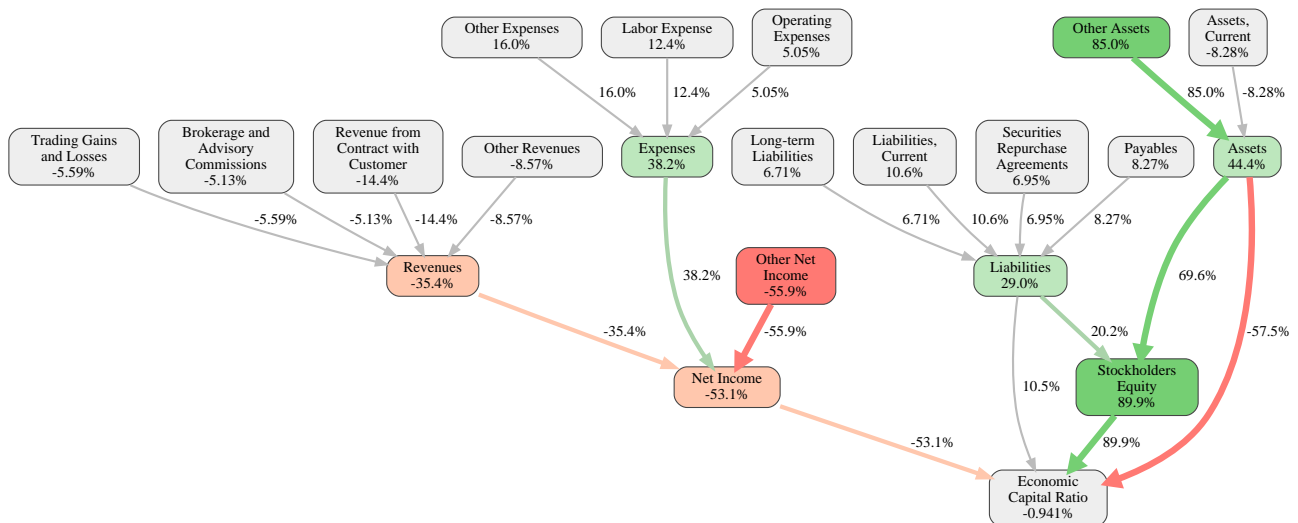

The relative strengths and weaknesses of WisdomTree Continuous Commodity Index Master Fund are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WisdomTree Continuous Commodity Index Master Fund compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 85% points. The greatest weakness of WisdomTree Continuous Commodity Index Master Fund is the variable Other Net Income, reducing the Economic Capital Ratio by 56% points.

The company's Economic Capital Ratio, given in the ranking table, is 124%, being 0.94% points below the market average of 125%.
