The greatest strength of RAYMOND JAMES FINANCIAL INC compared to the market average is the variable Receivables, increasing the Economic Capital Ratio by 82% points. The greatest weakness of RAYMOND JAMES FINANCIAL INC is the variable Liabilities, Current, reducing the Economic Capital Ratio by 97% points.

The company's Economic Capital Ratio, given in the ranking table, is 32%, being 158% points below the market average of 190%.
