

The relative strengths and weaknesses of RAYMOND JAMES FINANCIAL INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of RAYMOND JAMES FINANCIAL INC compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 69% points. The greatest weakness of RAYMOND JAMES FINANCIAL INC is the variable Liabilities, Current, reducing the Economic Capital Ratio by 93% points.

The company's Economic Capital Ratio, given in the ranking table, is 26%, being 131% points below the market average of 157%.
