### Invesco CurrencyShares Canadian Dollar Trust Rank 21 of 73



The relative strengths and weaknesses of Invesco CurrencyShares Canadian Dollar Trust are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Invesco CurrencyShares Canadian Dollar Trust compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 27% points. The greatest weakness of Invesco CurrencyShares Canadian Dollar Trust is the variable Revenues, reducing the Economic Capital Ratio by 23% points.

The company's Economic Capital Ratio, given in the ranking table, is 219%, being 62% points above the market average of 157%.
