

## GraniteShares Platinum Trust Rank 22 of 74

The relative strengths and weaknesses of GraniteShares Platinum Trust are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GraniteShares Platinum Trust compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 28% points. The greatest weakness of GraniteShares Platinum Trust is the variable Other Assets, reducing the Economic Capital Ratio by 37% points.

The company's Economic Capital Ratio, given in the ranking table, is 248%, being 55% points above the market average of 193%.
