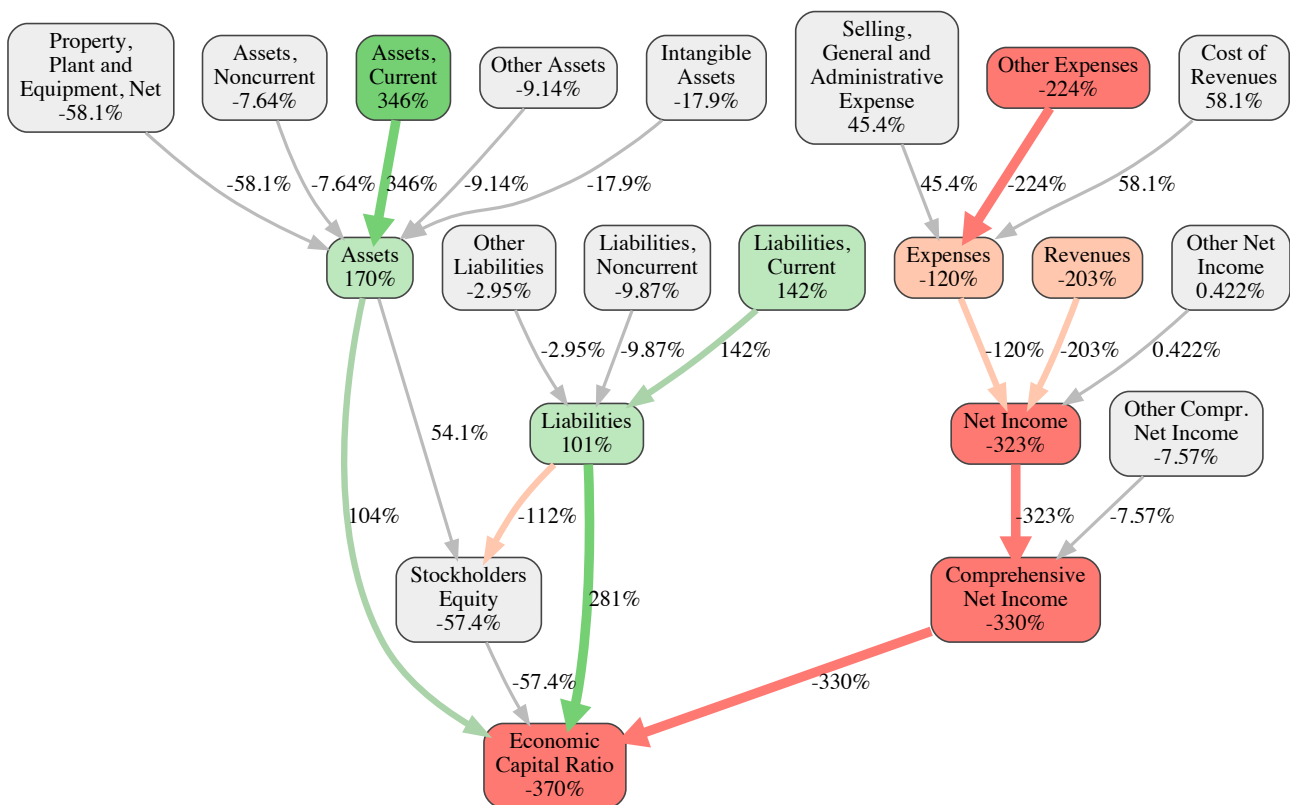

The relative strengths and weaknesses of Wave Sync Corp. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wave Sync Corp. compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 346% points. The greatest weakness of Wave Sync Corp. is the variable Net Income, reducing the Economic Capital Ratio by 323% points.

The company's Economic Capital Ratio, given in the ranking table, is -460%, being 370% points below the market average of -89%.
