The relative strengths and weaknesses of BRIDGEWAY NATIONAL CORP. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BRIDGEWAY NATIONAL CORP. compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 4,637% points. The greatest weakness of BRIDGEWAY NATIONAL CORP. is the variable Net Income, reducing the Economic Capital Ratio by 869% points.

The company's Economic Capital Ratio, given in the ranking table, is -1,345%, being 959% points below the market average of -386%.
