

The relative strengths and weaknesses of Yunhong CTI Ltd. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Yunhong CTI Ltd. compared to the market average is the variable Revenues, increasing the Economic Capital Ratio by 197% points. The greatest weakness of Yunhong CTI Ltd. is the variable Cost of Revenues, reducing the Economic Capital Ratio by 280% points.

The company's Economic Capital Ratio, given in the ranking table, is -66%, being 46% points above the market average of -113%.
