

The relative strengths and weaknesses of DUPONT E I DE NEMOURS & CO are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of DUPONT E I DE NEMOURS & CO compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 134% points. The greatest weakness of DUPONT E I DE NEMOURS & CO is the variable Liabilities, Current, reducing the Economic Capital Ratio by 16% points.

The company's Economic Capital Ratio, given in the ranking table, is 173%, being 103% points above the market average of 70%.
