

The relative strengths and weaknesses of SolarWindow Technologies Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SolarWindow Technologies Inc. compared to the market average is the variable Assets, Current, increasing the Economic Capital Ratio by 1,800% points. The greatest weakness of SolarWindow Technologies Inc. is the variable Net Income, reducing the Economic Capital Ratio by 782% points.

The company's Economic Capital Ratio, given in the ranking table, is -589%, being 659% points below the market average of 70%.
