

The relative strengths and weaknesses of JUNIPER NETWORKS INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of JUNIPER NETWORKS INC compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 116% points. The greatest weakness of JUNIPER NETWORKS INC is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 162% points.

The company's Economic Capital Ratio, given in the ranking table, is 287%, being 303% points above the market average of -16%.
