

International Business Machines Rank 21 of 27

The relative strengths and weaknesses of International Business Machines are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of International Business Machines compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 238% points. The greatest weakness of International Business Machines is the variable Liabilities, Noncurrent, reducing the Economic Capital Ratio by 127% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 107% points below the market average of 197%.
