

The relative strengths and weaknesses of ELECTRONICS FOR IMAGING INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ELECTRONICS FOR IMAGING INC compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 169% points. The greatest weakness of ELECTRONICS FOR IMAGING INC is the variable Revenues, reducing the Economic Capital Ratio by 100% points.

The company's Economic Capital Ratio, given in the ranking table, is 153%, being 44% points below the market average of 197%.
