

The relative strengths and weaknesses of JUNIPER NETWORKS INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of JUNIPER NETWORKS INC compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 231% points. The greatest weakness of JUNIPER NETWORKS INC is the variable Revenues, reducing the Economic Capital Ratio by 181% points.

The company's Economic Capital Ratio, given in the ranking table, is 201%, being 0% points below the market average of 201%.
