

The relative strengths and weaknesses of Evolv Technologies Holdings Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Evolv Technologies Holdings Inc. compared to the market average is the variable Asset Turnover, increasing the Economic Capital Ratio by 706% points. The greatest weakness of Evolv Technologies Holdings Inc. is the variable Revenues, reducing the Economic Capital Ratio by 310% points.

The company's Economic Capital Ratio, given in the ranking table, is 171%, being 32% points below the market average of 203%.
