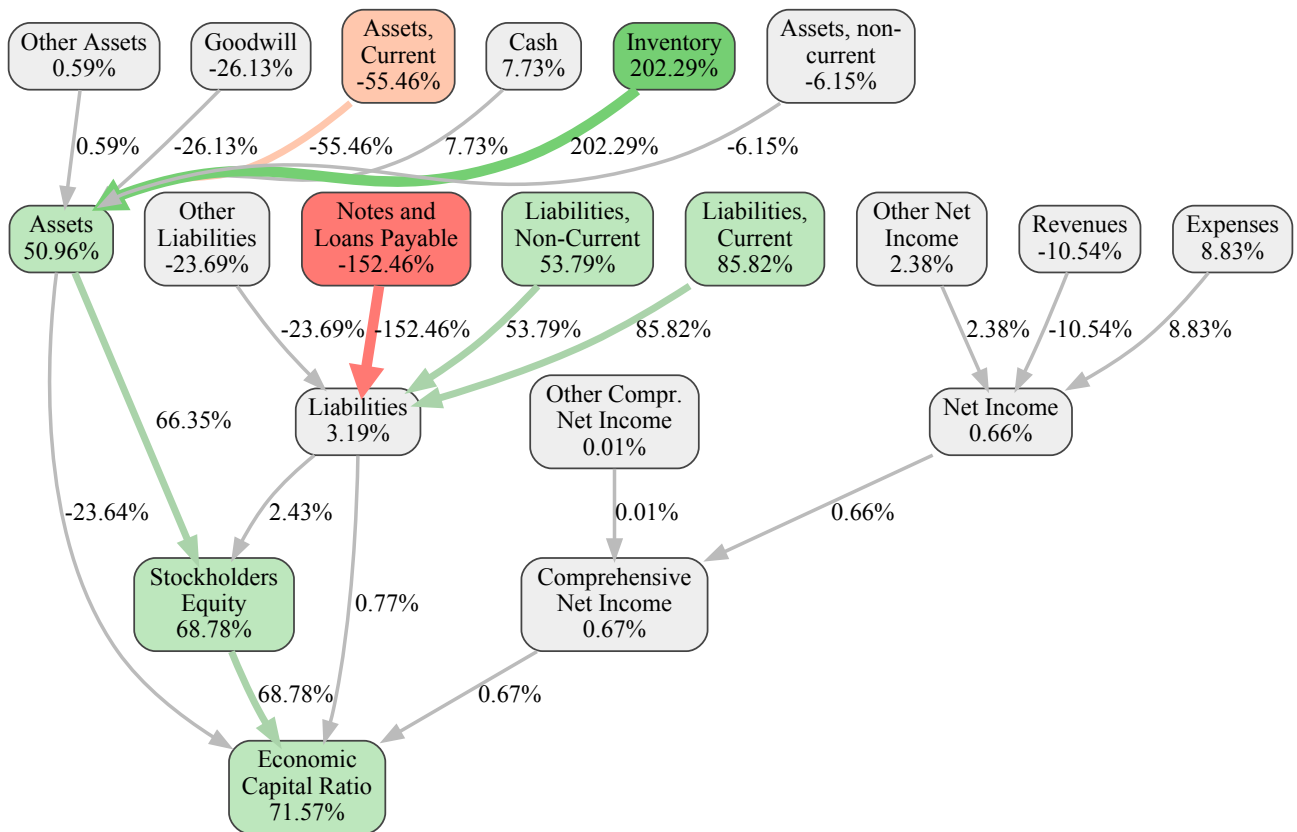

The relative strengths and weaknesses of Toll Brothers Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Toll Brothers Inc. compared to the market average is the variable Inventory, increasing the Economic Capital Ratio by 202% points. The greatest weakness of Toll Brothers Inc. is the variable Notes and Loans Payable, reducing the Economic Capital Ratio by 152% points.

The company's Economic Capital Ratio, given in the ranking table, is 190%, being 72% points above the market average of 119%.
