

The relative strengths and weaknesses of ATLAS TECHNICAL CONSULTANTS are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ATLAS TECHNICAL CONSULTANTS compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 100% points. The greatest weakness of ATLAS TECHNICAL CONSULTANTS is the variable Liabilities, Non-Current, reducing the Economic Capital Ratio by 78% points.

The company's Economic Capital Ratio, given in the ranking table, is -1.1%, being 6.7% points below the market average of 5.6%.
