





The relative strengths and weaknesses of SANFILIPPO JOHN B & SON INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SANFILIPPO JOHN B & SON INC compared to the market average is the variable Revenues, increasing the Economic Capital Ratio by 181% points. The greatest weakness of SANFILIPPO JOHN B & SON INC is the variable Expenses, reducing the Economic Capital Ratio by 116% points.

The company's Economic Capital Ratio, given in the ranking table, is 177%, being 81% points above the market average of 95%.
