

The relative strengths and weaknesses of VOYA INSURANCE & ANNUITY Co are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VOYA INSURANCE & ANNUITY Co compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 19% points. The greatest weakness of VOYA INSURANCE & ANNUITY Co is the variable Revenues, reducing the Economic Capital Ratio by 19% points.

The company's Economic Capital Ratio, given in the ranking table, is 3.1%, being 12% points below the market average of 15%.
