

### ATLANTIC AMERICAN CORP Rank 9 of 26

The relative strengths and weaknesses of ATLANTIC AMERICAN CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ATLANTIC AMERICAN CORP compared to the market average is the variable Premiums Earned, Net, increasing the Economic Capital Ratio by 136% points. The greatest weakness of ATLANTIC AMERICAN CORP is the variable Expenses, reducing the Economic Capital Ratio by 118% points.

The company's Economic Capital Ratio, given in the ranking table, is 7.6%, being 1.7% points above the market average of 5.9%.
