



The relative strengths and weaknesses of ATLANTIC AMERICAN CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ATLANTIC AMERICAN CORP compared to the market average is the variable Premiums Earned, Net, increasing the Economic Capital Ratio by 126% points. The greatest weakness of ATLANTIC AMERICAN CORP is the variable Expenses, reducing the Economic Capital Ratio by 106% points.

The company's Economic Capital Ratio, given in the ranking table, is 19%, being 12% points above the market average of 7.5%.
