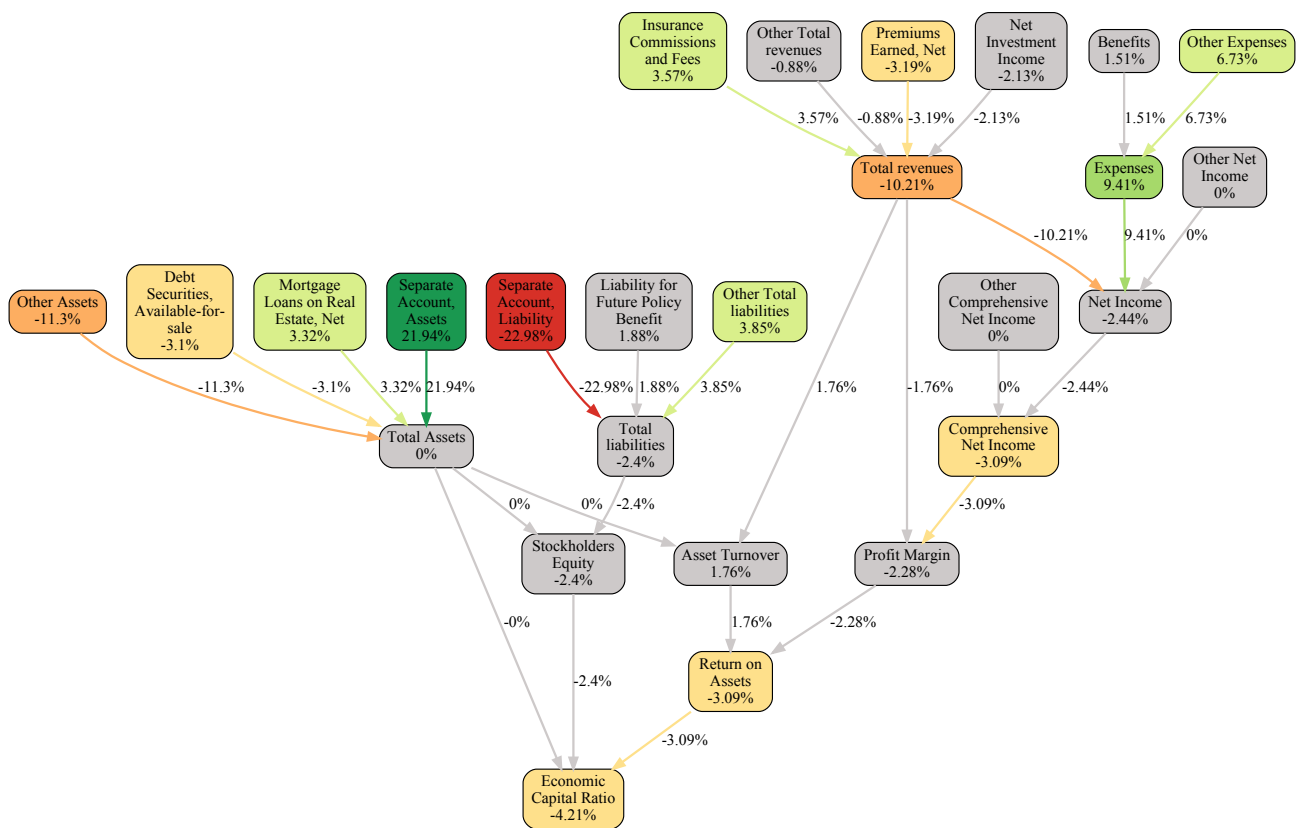

## BRIGHTHOUSE LIFE INSURANCE Co Rank 19 of 23



The relative strengths and weaknesses of BRIGHTHOUSE LIFE INSURANCE Co are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BRIGHTHOUSE LIFE INSURANCE Co compared to the market average is the variable Separate Account, Assets, increasing the Economic Capital Ratio by 22% points. The greatest weakness of BRIGHTHOUSE LIFE INSURANCE Co is the variable Separate Account, Liability, reducing the Economic Capital Ratio by 23% points.

The company's Economic Capital Ratio, given in the ranking table, is 2.4%, being 4.2% points below the market average of 6.6%.
