



The relative strengths and weaknesses of Rancho Santa Fe Mining Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rancho Santa Fe Mining Inc. compared to the market average is the variable Cost of Revenue, increasing the Economic Capital Ratio by 6.0% points. The greatest weakness of Rancho Santa Fe Mining Inc. is the variable Other Assets, reducing the Economic Capital Ratio by 57% points.

The company's Economic Capital Ratio, given in the ranking table, is -278%, being 197% points below the market average of -81%.
