




ADAMANT DRI PROCESSING & MINERALS GROUP Rank 52 of 92











The relative strengths and weaknesses of ADAMANT DRI PROCESSING & MINERALS GROUP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ADAMANT DRI PROCESSING & MINERALS GROUP compared to the market average is the variable Expenses, increasing the Economic Capital Ratio by 39% points. The greatest weakness of ADAMANT DRI PROCESSING & MINERALS GROUP is the variable Liabilities, Current, reducing the Economic Capital Ratio by 120% points.

The company's Economic Capital Ratio, given in the ranking table, is -74%, being 20% points above the market average of -94%.
