

The relative strengths and weaknesses of McEwen Mining Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of McEwen Mining Inc. compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 135% points. The greatest weakness of McEwen Mining Inc. is the variable Property, Plant and Equipment, reducing the Economic Capital Ratio by 14% points.

The company's Economic Capital Ratio, given in the ranking table, is 195%, being 247% points above the market average of -52%.
