

## PATRIOT GOLD CORP Rank 10 of 80



The relative strengths and weaknesses of PATRIOT GOLD CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PATRIOT GOLD CORP compared to the market average is the variable Liabilities, Current, increasing the Economic Capital Ratio by 86% points. The greatest weakness of PATRIOT GOLD CORP is the variable Other Expenses, reducing the Economic Capital Ratio by 54% points.

The company's Economic Capital Ratio, given in the ranking table, is 182%, being 234% points above the market average of -52%.
