

Wolverine Resources Corp. Rank 77 of 80



The relative strengths and weaknesses of Wolverine Resources Corp. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wolverine Resources Corp. compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 785% points. The greatest weakness of Wolverine Resources Corp. is the variable Property, Plant and Equipment, reducing the Economic Capital Ratio by 180% points.

The company's Economic Capital Ratio, given in the ranking table, is -460%, being 408% points below the market average of -52%.
