The relative strengths and weaknesses of AMERICAN AXLE & MANUFACTURING HOLDINGS INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of AMERICAN AXLE & MANUFACTURING HOLDINGS INC compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 197% points. The greatest weakness of AMERICAN AXLE & MANUFACTURING HOLDINGS INC is the variable Cost of Goods and Services Sold, reducing the Economic Capital Ratio by 245% points.

The company's Economic Capital Ratio, given in the ranking table, is -33%, being 36% points below the market average of 2.3%.
