

The relative strengths and weaknesses of ANADARKO PETROLEUM CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ANADARKO PETROLEUM CORP compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 88% points. The greatest weakness of ANADARKO PETROLEUM CORP is the variable Depreciation, Depletion, Amortization, reducing the Economic Capital Ratio by 61% points.

The company's Economic Capital Ratio, given in the ranking table, is 158%, being 290% points above the market average of -132%.
