

The relative strengths and weaknesses of Texas South Energy Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Texas South Energy Inc. compared to the market average is the variable Property, Plant and Equipment, increasing the Economic Capital Ratio by 382% points. The greatest weakness of Texas South Energy Inc. is the variable Net Income, reducing the Economic Capital Ratio by 246% points.

The company's Economic Capital Ratio, given in the ranking table, is -206%, being 74% points below the market average of -132%.
