

PHX MINERALS INC. Rank 15 of 114



The relative strengths and weaknesses of PHX MINERALS INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of PHX MINERALS INC. compared to the market average is the variable Other Revenues, increasing the Economic Capital Ratio by 156% points. The greatest weakness of PHX MINERALS INC. is the variable Oil and Gas Property, reducing the Economic Capital Ratio by 155% points.

The company's Economic Capital Ratio, given in the ranking table, is 276%, being 282% points above the market average of -6.0%.
