

The relative strengths and weaknesses of TELLURIAN INC. DE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of TELLURIAN INC. DE compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 270% points. The greatest weakness of TELLURIAN INC. DE is the variable Operating Expenses, reducing the Economic Capital Ratio by 260% points.

The company's Economic Capital Ratio, given in the ranking table, is -264%, being 202% points below the market average of -62%.
