




## EVERFLOW EASTERN PARTNERS

The relative strengths and weaknesses of EVERFLOW EASTERN PARTNERS LP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of EVERFLOW EASTERN PARTNERS LP compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 128% points. The greatest weakness of EVERFLOW EASTERN PARTNERS LP is the variable Other Revenues, reducing the Economic Capital Ratio by 81% points.

The company's Economic Capital Ratio, given in the ranking table, is 234%, being 296% points above the market average of -62%.
