

The relative strengths and weaknesses of Trillion Energy International Inc. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Trillion Energy International Inc. compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 252% points. The greatest weakness of Trillion Energy International Inc. is the variable Operating Expenses, reducing the Economic Capital Ratio by 362% points.

The company's Economic Capital Ratio, given in the ranking table, is -138%, being 76% points below the market average of -62%.
