

## MEXCO ENERGY CORP Rank 14 of 89



The relative strengths and weaknesses of MEXCO ENERGY CORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MEXCO ENERGY CORP compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 300% points. The greatest weakness of MEXCO ENERGY CORP is the variable Operating Expenses, reducing the Economic Capital Ratio by 155% points.

The company's Economic Capital Ratio, given in the ranking table, is 131%, being 335% points above the market average of -204%.
