The greatest strength of Sustainable Projects Group Inc. compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 774% points. The greatest weakness of Sustainable Projects Group Inc. is the variable Operating Expenses, reducing the Economic Capital Ratio by 592% points.

The company's Economic Capital Ratio, given in the ranking table, is -233%, being 259% points below the market average of 26%.
