

The relative strengths and weaknesses of PHX MINERALS INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all var_labels having an effect on the Economic Capital Ratio.

The greatest strength of PHX MINERALS INC. compared to the market average is the variable Oil and Gas Property, increasing the Economic Capital Ratio by 141% points. The greatest weakness of PHX MINERALS INC. is the variable Other Expenses, reducing the Economic Capital Ratio by 134% points.

The company's Economic Capital Ratio, given in the ranking table, is -36%, being 77% points above the market average of -113%.
