

The relative strengths and weaknesses of CIVITAS RESOURCES INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all var_labels having an effect on the Economic Capital Ratio.

The greatest strength of CIVITAS RESOURCES INC. compared to the market average is the variable Other Expenses, increasing the Economic Capital Ratio by 220% points. The greatest weakness of CIVITAS RESOURCES INC. is the variable Operating Expenses, reducing the Economic Capital Ratio by 94% points.

The company's Economic Capital Ratio, given in the ranking table, is 251%, being 364% points above the market average of -113%.
