

The relative strengths and weaknesses of OFFICE PROPERTIES INCOME TRUST are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of OFFICE PROPERTIES INCOME TRUST compared to the market average is the variable Other Net Income, increasing the Economic Capital Ratio by 111% points. The greatest weakness of OFFICE PROPERTIES INCOME TRUST is the variable Revenues, reducing the Economic Capital Ratio by 80% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 78% points above the market average of 16%.
