

The relative strengths and weaknesses of REDWOOD MORTGAGE INVESTORS VIII are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of REDWOOD MORTGAGE INVESTORS VIII compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 107% points. The greatest weakness of REDWOOD MORTGAGE INVESTORS VIII is the variable Other Assets, reducing the Economic Capital Ratio by 154% points.

The company's Economic Capital Ratio, given in the ranking table, is 314%, being 701% points above the market average of -387%.
