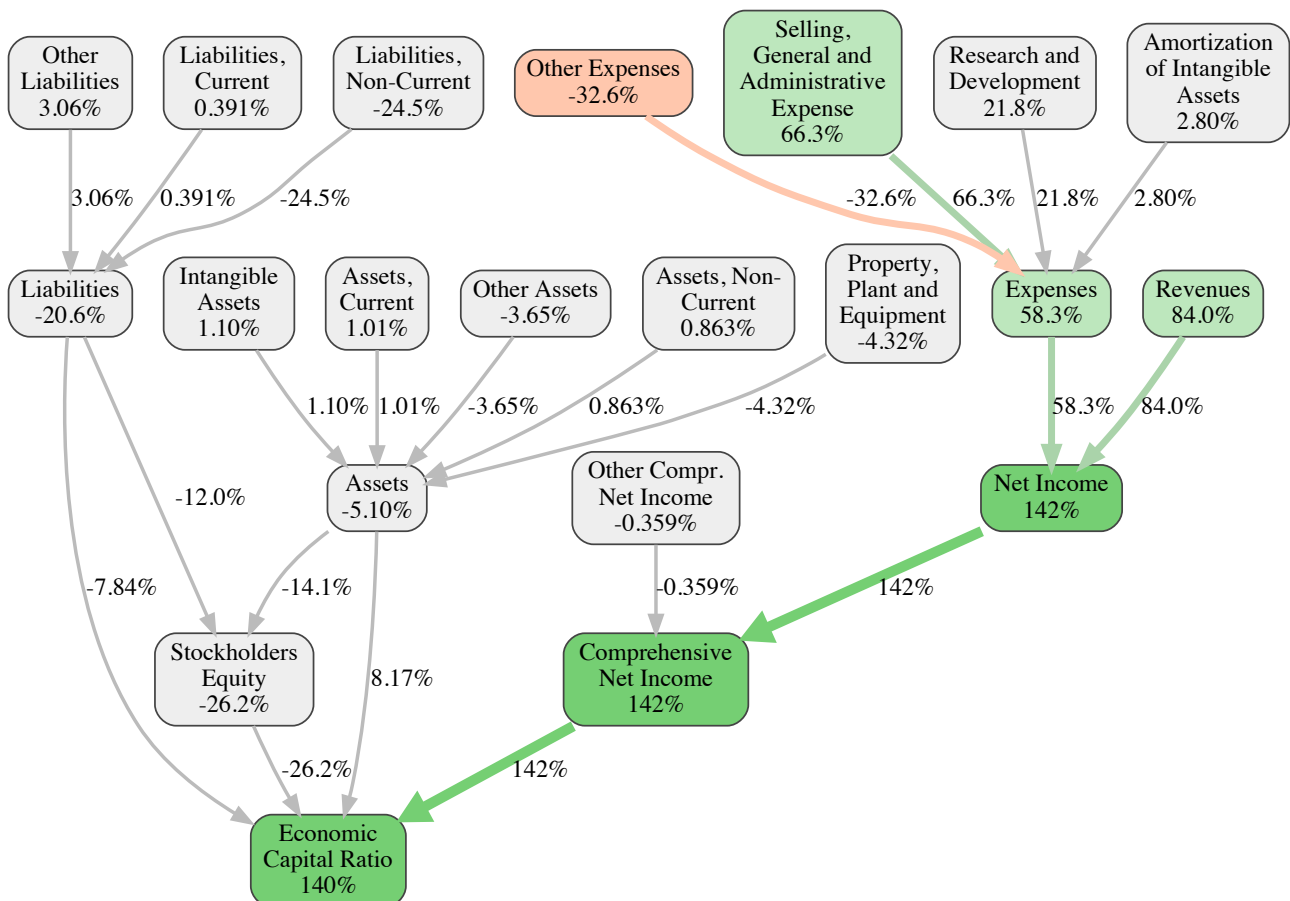

The relative strengths and weaknesses of APPLIED MATERIALS INC DE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of APPLIED MATERIALS INC DE compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 142% points. The greatest weakness of APPLIED MATERIALS INC DE is the variable Other Expenses, reducing the Economic Capital Ratio by 33% points.

The company's Economic Capital Ratio, given in the ranking table, is 136%, being 140% points above the market average of -4.9%.
