

The relative strengths and weaknesses of COLUMBIA BANKING SYSTEM INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of COLUMBIA BANKING SYSTEM INC. compared to the market average is the variable Assets and Securities, increasing the Economic Capital Ratio by 9.4% points. The greatest weakness of COLUMBIA BANKING SYSTEM INC. is the variable Other Assets, reducing the Economic Capital Ratio by 5.1% points.

The company's Economic Capital Ratio, given in the ranking table, is 10%, being 2.7% points above the market average of 7.7%.
