FIFTH THIRD BANCORP Rank 52 of 180



The relative strengths and weaknesses of FIFTH THIRD BANCORP are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of FIFTH THIRD BANCORP compared to the market average is the variable Assets and Securities, increasing the Economic Capital Ratio by 15% points. The greatest weakness of FIFTH THIRD BANCORP is the variable Liabilities and Borrowings, reducing the Economic Capital Ratio by 13% points.

The company's Economic Capital Ratio, given in the ranking table, is 7.5%, being 0.83% points above the market average of 6.6%.
