

FIRST HAWAIIAN INC. Rank 44 of 180



The relative strengths and weaknesses of FIRST HAWAIIAN INC. are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of FIRST HAWAIIAN INC. compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 15% points. The greatest weakness of FIRST HAWAIIAN INC. is the variable Liabilities and Borrowings, reducing the Economic Capital Ratio by 15% points.

The company's Economic Capital Ratio, given in the ranking table, is 7.6%, being 0.99% points above the market average of 6.6%.
