The relative strengths and weaknesses of UNITED COMMUNITY BANKS INC are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of UNITED COMMUNITY BANKS INC compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 16% points. The greatest weakness of UNITED COMMUNITY BANKS INC is the variable Liabilities and Borrowings, reducing the Economic Capital Ratio by 16% points.

The company's Economic Capital Ratio, given in the ranking table, is 7.1%, being 0.51% points above the market average of 6.6%.
