

The relative strengths and weaknesses of CITIZENS HOLDING CO MS are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of CITIZENS HOLDING CO MS compared to the market average is the variable Assets and Securities, increasing the Economic Capital Ratio by 20% points. The greatest weakness of CITIZENS HOLDING CO MS is the variable Liabilities and Borrowings, reducing the Economic Capital Ratio by 16% points.

The company's Economic Capital Ratio, given in the ranking table, is 4.6%, being 2.0% points below the market average of 6.6%.
